1. Page 22, Section II Bid Data Sheet, ITS Clause 11.1 (h):

The wordings "lease hire agreement" has been deleted.

2. Page 35, Letter of Price bid:

In case out of station (out side parsa and Siraha), the driver will be paid per diem as per NNJS Rules. However, no payment shall be made for with the district.

5. Page 42, Employer's Requirement, Bullet 32

Following bullet 32 has been added after bullet 31:

In case of schools closer in project catchment area due to any natural calamities or pandemic, vehicles will not be hired and NNJS will not be liable to pay any cost over such school closure period.
